Alcoholic beverages, including any alcoholic beverages included as part of the ticket price, must be sold by the licensee or permittee whose premises is being used to conduct the event Permit is valid for 36 hours Authorized non-profit entities may obtain not more than two permits on an annual basis The permit has a fee of \$100
